| 11082 | Buildings and Land Matters a. 49/51 High Street Extension/alterations Update A councillor commented that this would need to be postponed as there was a large costs to the proposal expected. He stated that any proposal would need to be included in a revised Business plan with funds either available or ear marked as available at a future date. The chair of finance stated that with the borrowing approval format the Town Council would need to consult with its residents prior to borrowing any funds. b. Cemetery update (non confidential matters only) A councillor commented again that this would probably need to be postponed or planned for in the revised Business Plan in order that the large costs expected (around £500,000 for costs alone on top of purchase of land). This would be subject to a loan and consultation with the residents. c. Street Lighting Update The report had been circulated to all prior to the meeting and was noted by all. d. High Street Toilets Update (purchase & refurbishment) The update as circulated was noted by all present and the chair clarified that the committee were now awaiting the quotes to be returned. e. Charitable Trust Wannock Office/Pavilion Update The report was circulated to all prior to the meeting and noted | |

by all present. The clerk added that one person had come forward since the report was made.

f. Centenary Field update

The report was circulated prior to the meeting and noted by all present. The chair updated and stated that the press release now mentioned the involvement of RBL as partners to Fields In Trust and he hoped the weather was good on the day.

g. Gosford Way Allotment Update

The report was circulated to all prior to the meeting and noted by all present. The clerk stated that the letter had now been received from Wealden and this would be put on the next full council possible for agreement to maintain the land near to the car park.

h. Vandalism update

The report was circulated prior to the meeting and noted by all present. A councillor commented that it was a remote area and there was no electricity for CCTV etc. A councillor commented that the PCSO had agreed to move the congregating youth/people from the church yard bench also and the church had agreed to monitor this also.

i. Oakleaf Park update and decision required

A report had been circulated to all councillors prior to the meeting and noted by all present. A councillor stated that the equipment had been there for many years and would need replacing when funds permitted. He felt that it was a vital park for the North of Polegate and should be replaced. He stated that any items that became dangerous should obviously be replaced or removed.

The clerk stated that they were not dangerous but were at the end of their life.

A councillor commented that the site was important and that he had a request from the school children for swings there.

A councillor commented that the school children also used the park and the park should still be aimed at small to junior aged children.

A councillor commented that there was no budget for this and it should be included in the business plan for replacement.

j. Wannock Play Area update

A report had been circulated prior to the meeting and noted by all present.

k. Skate Park Update

A report had been circulated prior to the meeting and noted by all present. A councillor commented on the litter in Black path and asked for a bin. The chair stated that council had agreed due to costs not to provide any extra bins or dog bins but that the councillor could put in a motion for a request to council for a future meeting.

l. Drainage at War Memorial Recreation Ground Update

A report had been circulated to all councillors and noted by all present. The clerk was asked about riparian rights and she explained this briefly. It was agreed that at the moment this item may be put on the business plan but should not be high
