<b>11033</b>	<b>Buildings and Land Matters</b> <b>a) Polegate War Memorial Recreation Ground</b> <b>i) Business rtes – office area, storage of files</b> It was recommended that a few files be moved to the office area at Wannock to reduce the council tax charges under the new regulations. <b>VOTE All in favour (FOR : Cllrs T Voyce, M Clewett, Mrs J Voyce, H Parker, Mrs M Piper, M Cunningham, J Harmer, J O’Riordan, E Board)</b>  <b>Standing orders suspended</b> Mr Woolmer mentioned that if there were any queries about the Centenary field and the charitable and non charitable status he would be able to answer those questions and reassured council that this was only a deed of dedication. <b>Standing orders reinstated</b> <i>Cllr O Riordan returned to the room at 8.57 pm</i> <i>Cllr M Clewett returned to the room at 8.58 pm</i> <b>ii) Field In Trust Centenary Field</b> The chair read out the merits and implications of a Centenary field. The committee then discussed the merits of the Centenary field and how it would tie in nicely with the commemoration of the first world war. Many had concerns about new legislation coming in that could mean green spaces could be built on by developers and many village greens had already been built on. Some councillors had concerns about Charitable trusts and the potential lack of interest from the general public of being on a trust board. The committee discussed the need to sign the deed within 6 months of being accepted. The cost was only around £80 if the deed and application form were completed in the	<b>JO</b>

office. A plaque would be provided free of charge by Fields in Trust. A councillor commented that this area of land had caused many ill feeling and issues over the years and this would resolve a number of those issues and stated that he would support the field only as there were other issues with the buildings there that needed to be resolved. A councillor commented that this was an opportunity to resolve many differences across the town and this could be done without any onerous conditions if the council focused on the field only. He stated that it did not adversely affect the council. He stated that this could reassure the people with doubts what the council may determine the use of the area to be. A councillor stated that a number of fields locally had been dedicated and safe guarded and with concerns about future legislation she was in support of the field being dedicated. A councillor commented that she was in full support of the dedication of the filed and that the council were also looking at whether a charitable trust would work for the Pavilion and Office area, but there were concerns that there would not be enough residents to be trustees to run the field and buildings. There was a huge amount of outgoings and the trust may end up having to fund raise just to pay for minor repairs, which the council were able to do by employing its maintenance person. A councillor commented that these Centenary projects were in co operation with the Royal British Legion and he was in full support of the idea of the deed of dedication. He had hoped that Polegate would be the first or one of the first to do this. A number of councillors reiterated that this was for the field only. The buildings would be looked at later. It was agreed that to ensure the swift approval of the recommendation the Mayor would call a special full council as soon as possible to approve the recommendations in the minutes.

**iii) Charitable Trust – Office and/or Land**

A councillor stated that there may not be enough interest in becoming a trustee and running the buildings. A councillor stated that the sports clubs themselves may be interested if they could be shown where some of the funding may come from. The council may be able to maintain control/title of the buildings but the trustee committee may be able to run them. A councillor stated that to progress the Centenary field would take priority, but the clerk could look into funding options for charitable trusts and the types of trusts and who may be interested in becoming trustees and report back to the committee or full council as appropriate.

A councillor commented that all of the assets needed looking at especially in view of the fact that the council were purchasing the High Street toilets.  Councillor agreed that the alteration/extension would need looking at but that there were alternatives to the extension and all options should be properly discussed by a working group in the future and options narrowed down to one, which would be drawn up and fully costed out by an architect. A councillor commented that the clerk already hired out the chambers and this could be done with a new meeting room and 51 High Street. A councillor commented that drawings of potential alterations had already been done and these should also be considered as an option. A councillor commented that there would be a loss of car parking and the turning point if there was an extension. A councillor commented that a good business plan should go to 20-30 years and this should include a future use that the council should consider. A councillor commented that there may be the possibility of using other land for parking.</p> <p><b>It was recommended that the clerk investigate the feasibility of the options listed for the development of the High Street site (49/51 High Street).
