He stated that he was going to draw up a list of useful topics to discuss. He reported that he had officially opened the lounge and dining areas (recently refurbished) at Bernhard Baron homes and opened their fete on the Saturday. He reported that on 22nd June that he had been invited with his wife Valerie to attend High tea and Ashdown Park Hotel to celebrate the 40th birthday of Wealden District Council. He stated that it had been a busy start but that he and his wife Valerie had enjoyed the occasions very much. He stated that he had also been invited to open Queensmead fete later in the year and he had also discovered that a number of residents in the homes would reach 100 this year and he had asked the school if they would enter a competition to design a card for these residents with a small prize from the Mayor. <p>11020</p>	<p>Motions proposed by resident at Annual Town Assembly and subsequent motions from councillors. The full list of motions was discussed with the addition of the slip road and full comprehensive review of the junctions. A councillor commented that the Town Council had submitted many comments over the years but these had always been ignored. It was resolved to submit all four motions to East Sussex County Council Highways authority as follows: That Council submit a letter to the Highways Authority, making the crossroads, in relation to the traffic flow from the High Street, a staggered crossing so that cars can cross in the same manner that they do on the main road. In addition to the above to add a submission to request ESCC Highways authority to carry out a feasibility study. To count the number of vehicles, to see that the problems</p>	

	<p>at the crossroads are and to establish that Polegate has a problem and come up with ideas to help solve it. In addition to both a & b above to submit a request that Highways widen the road to allow for larger vehicles to pass alongside each other¹ In addition to the above to request ESCC Highways authority look at the options of improving the junction for people turning out of Wannock and out of Polegate and to ask from the survey, what are the drawbacks for improving this junction.² Supplementary suggestion to create a slip road for traffic turning left into Eastbourne Exiting Polegate High Street at the Crossroads and to ask East Sussex County Council Highways Department to look at the whole junctions from Cophall Roundabout (Highways Agency) to the crossroads with a view to changing the lights phasing and to come back to Polegate Town Council with proposals. 11021	<p>Corporate comment to Highways Agency and Department of Transport regarding the Town Council view of potential improvements to the A22/A27 The council discussed the comments issues by the two local MPs. Most councillors considered that the A27 should be made into a dual carriageway. It was previously designated as a superhighway. Councillors felt that the Cophall roundabout (underpass) should be looked at again as well. A councillor stated that she did not feel that a dual carriageway would make the road safer. Another councillor stated that because it was single road it tempted people to overtake slow traffic in dangerous places. It was resolved to submit a letter to the Highways Agency, Department of transport and the local MPs stating that the Town Council were in support of making the A27 locally dual carriageway and to improve the Cophall roundabout, particularly with regards to the underpass. The council agreed that the Advice Bureau did very good work, but Polegate was now only supplied by the children’s centre now and their accounts looked very healthy.</p> <p>It was resolved not to grant the request at this stage. The clerk was asked to write and advise that the refusal did not preclude Wealden Citizens Advice form applying for another grant after 6 months. 11024	<p>Cllr Harmer returned to the room at 8.14pm</p> <p>Motion to submit request to ESCC for a permanent right of way (definitive map) to be added for the twitten and access to porters way from the High Street, across the car park and through the twitten leading to porters way.</p> <p>The motion was considered whether this would be the best way forward and whether the council should contact the landowner. The clerk stated that she had been told by ESCC that this would only result in an informal agreement as is in place now and to have a permanent right of way the process would have to be carried out formally. There were no costs to the council as ESCC would do the formal and legal side of things once the request was submitted. Some councillors were concerned that this would cause issues with the landowner and legal reasons why the residents may not be able to use the right of way. The clerk confirmed that the council would have to seek evidence that this had been used by at least 20 people over the period of time stated in the application pack. Cllr D Shing and S Shing, declared interests as they were County Councillors and may view the application in the future if it came back for them as local members. A proposal was put to go ahead and submit the application as it stood with a second application for Gilda Crescent to be submitted. The motion was seconded. 11026	<p>Section 106 money – potential uses a) Age Gym – Polegate War Memorial recreation Ground The Mayor commented that a committee may be needed to have a look at the gym in more detail. A councillor stated that he had concerns about it being tucked behind the garage and he would like to see the garage resited next to the maintenance person's garage and have extra equipment to make a feature of the age gym. He stated that he had been around to see a number of age gyms in Sussex and they seemed to be very popular and heavily used. He stated that he thought it would be very good use of the s106 money. He stated that there may be an issue with the cost of a new garage. The Mayor asked if there was money for moving of the garage. The clerk stated that there was no funding for that only from general reserves, but that there were some ear marked reserves not being used (office maintenance) but that would have to be approved by council if deemed appropriate. She stated that she had got some basic prices for a replacement garage and that was around £5000 upwards. A councillor stated that he was in full support of a small group of councillors having a look at the equipment and the location, the size of the area and to look at the equipment as a whole. A councillor stated that there had been a lot of work to put in the information that was in the background papers, built up from what the council had asked for over a long period of time. It was suggested that four councillors Cllrs Mrs J Voyce, Mrs M Piper, T Voyce and J O'Riordan be selected to look at the age gym in more detail. A councillor stated that he thought other areas should be looked at and it should be called and any age gym. The Mayor stated that it had already been resolved that it would go at Wannock Road and that the other areas had already been looked at, at other meetings and dismissed for various reasons. The clerk confirmed that it had been resolved at previous committees and approved by full council and Council have resolved not to do any work at Brightling Road until the drainage issue was resolved and a reserve was already in place for this. It was resolved that Cllrs Mrs J Voyce, Mrs M Piper, T Voyce and J O'Riordan would look at the age gym and the moving of the garage in detail and bring this back to full council for approval at a later date. 	<p>Southfields Residents Group meetings and had been asked to out this forward on their behalf and he hoped that the council would support this request. The Mayor asked if there was a budget for additional bins and how much would they cost. The clerk stated that the costs were £5.05 per emptying (£262.60 per annum) and Wealden supply the bin for free. A councillor stated that there was a bin at the top of Southfields and there was always litter around and not in the bin and she felt that a new bin was unlikely to be used properly. A councillor asked if the Town Council could supply their own. The clerk stated that because Wealden District Council were responsible for waste management it should be done through them, in some instances this could be done, as with McDonalds and the sponsoring of a bin on the highways. In that instance a licence had been obtained from highways and authority from Wealden District Council and the litter picker had been asked prior to that if he would be able to empty that bin. As the litter picker was already over full capacity, it would not be something that she could recommend to council and it would have to go to the personnel committee first for approval. The provision of bins in general was discussed and it was agreed that rather than providing bins on request the whole area should be looked at with regards to locations as there may be more deserving areas that need looking at. A councillor remarked that the reason for making a policy for no further dog bins was related to individual requests coming in for other bins. A councillor stated that if the aim was to have a litter free town, the Town Council would have to out litter bins in. A councillor suggested that a litter bin be put in that location for a year and if it was well used to continue funding it. A councillor commented that if council decided to put a bin in this location, in the meantime the locations of the bins should be looked at and review regularly where any new bins may need to go. A councillor stated that the Town Council should be looking at where areas of litter are building up and then consider whether to put bins in those locations.</p> <p><u>A proposal was made to put a bin in this location.
