11569	<p>2016 Garden & Allotment Competitions</p> <p>The report had been circulated prior to the meeting.</p> <p>It was resolved to run Polegate's best garden and allotment competition in 2016. To add a new category "best back garden" at a cost of around £50 (prize vouchers). This would form best front garden, best back garden and best allotment.</p> <p>To allow residents to enter the competition either themselves or nominations from others. Councillors should be encouraged to put forward front gardens for judging.</p> <p>To advertise that there will be a competition in late May and throughout until the competition closes in mid July.</p> <p>Allotment representatives (Cllr Dunbar & Bennett) to have input in putting forward best allotments by keeping notes and pictures of allotments throughout the year while visiting the allotments.</p> <p>A small group of councillors 3-5 maximum to go around and judge the gardens and allotments in late July/early August. If a large number of residents enter, these areas may be divided up into areas first to be shortlisted.</p> <p>To hold a presentation evening for the allotment and garden winners in early September. Inviting winners and a guest and all councillors and to provide drinks and light refreshments on the night. The Mayor to present the vouchers and a certificate to the winners only.</p> <p>A certificate and garden vouchers of £25, £15 and £10 for 1st 2nd and 3rd prize respectively each for the best back garden, best front garden and best allotment. Where appropriate a certificate will be presented for highly commended.</p> <p>Cllr Dunbar and he Town Clerk to be delegated to design the posters and entry form and finalise dates and sundry matters.</p> <p>Press releases to be done throughout along with website</p>
