10893	Planning Applications WD/2014/0153/MAJ Natewood Farm, Polegate Road, Hailsham BN27 3PH Construction of a solar park, to include the installation of solar panels to generate up to 8.8MW of electricity with transformer housings, security fencing and cameras, landscaping and other associated works and cable route/trench A discussion took place on the merits of solar power and the location of the proposed solar farm. A councillor commented that it was unlikely to be seen from the road, the area was flat and renewable energy (solar) was favoured over wind turbines. Sheep were able to graze under the panels and the farm would be unlikely to render the soil sterile. A councillor asked what the efficiency of solar was. Another councillor commented that although he was not an expert he understood that solar was about 35-36% efficiency. Councillors commented that they preferred solar farms over wind turbines as they were less intrusive. A councillor commented that she was concerned over the environmental effects as it was so close to Ogs wood, where there were interesting species. The chair stated that he had attended the Wealden briefing which included information on solar farms. He stated that once the grid was full no more could be added, so there were likely to be a number of applications coming through. Cllr J Harmer arrived at 7.37pm
