However, the council made the decisions subject to the public consultation that will follow by ESCC as the review is to be in line with public opinion.  <b>Location J Brook Street Eastern End</b> A proposal was made to accept the draft plan and was seconded A proposal was then made to accept the draft plan with amendments reinstating the 3 car parking spaces in Victoria Road next to the Doctors surgery but make it subject to the public response and was seconded After further discussion the first proposal was withdrawn  <b>It was resolved to accept the Location J plan as drafted with amendments to reinstate the 3 car parking spaces in Victoria Road next to the Doctors surgery and subject to the responses received by ESCC at their public consultation stage.
