**8908 Declarations of interest in any items on the agenda**  
There were none.

**8909 Minutes of the meeting held on 21<sup>st</sup> October 2009**  
The minutes of the meeting held on 21<sup>st</sup> October 2009 were adopted as a correct record and signed by the Chair.  
Cllr Voyce proposed that Cllr Mrs J Voyce be co-opted on to the Planning Committee under Standing Order 26h Resolution moved without Notice.

**It was recommended that Cllr Mrs J Voyce be co-opted on to the Planning Committee**

Cllr Voyce proposed that Standing Orders be suspended to enable members of the public to comment.

**SUSPEND STANDING ORDERS**

The applicant for 1 Northfields spoke regarding her planning application. The resident stated that the roof space would become the main bedroom and the existing bedroom would become the dining room, therefore no more bedrooms would be created. The velux windows that would be put in would not overlook other properties. These improvements would create a better environment in the living space for the occupants.

A resident wished to speak against the proposed planning application for 1 Northfield. The resident stated that the plot had a quite a long history and there had been a few applications. When the planning permission was granted in 2008 it was for a single storey only and no living in the roof space. This new application goes against the original application and is overdevelopment of the site. This application should not have been allowed to come to us as WDC should have looked at the original application. The resident requested that a strong message be sent to WDC stating that Polegate Residents are not going to allow this sort of overdevelopment to take place.

A second resident wished to speak against the application for 1 Northfield. Before the resident spoke about the application he wished to raise the matter of a procedural nature. It was regarding the original application for 1 Northfield and Cllr J Rogers declaring an interest. The resident requested that Cllr Rogers informed the Council and members of the public why this had not been done this time. The

resident then stated that he had no confidence in the planning procedure as the original application stated no living in the roof space and yet this application is going against that. The turning circles had not been adhered to as per the original application and no enforcement had been undertaken by WDC. The property is situated near a play park and the exit on to the main road is inadequate for this property. He stated that the question should be asked why this had even got to Polegate Town Council for consideration as it was going against the original application and he felt that it was a waste of time for both members of the public and Council.
