##### **Reinstate Standing Orders**

#### **9017 Minutes of the Meeting Held on 14<sup>th</sup> December 2009**

These minutes had been discussed at the previous Council Meeting on January 2010. The amendments had been agreed. The Clerk added the Amendment on item 8934 in the last bullet point.

**It was resolved by 9 for and 4 abstentions (Cllrs Shing, Watkins, Martin and Mrs Berry) to adopt the minutes of the 14<sup>th</sup> December with the amendments that had been agreed on 25<sup>th</sup> January 2010 together with item 8934, last bullet point, which read –  
An Agreement from the Pre-School to proceed (or not) on the terms and conditions set by the Council.**

## **9018 Polegate War Memorial Recreation Ground**

### **a) Town and Village Green Application**

**It was resolved by 9 in favour and 4 against (Cllrs Shing, Watkins, Martin and Mrs Berry) that Polegate Town Council object to the application for the registration of the Polegate War Memorial Recreation Ground as a Town and Village Green.**

**It was resolved by 9 in favour and 4 against (Cllrs Shing, Watkins, Martin and Mrs Berry) that we engage our Legal Representative to represent Polegate Town Council in this matter and that we instruct them to submit a letter of objection to ESCC by 25<sup>th</sup> February 2010 on our behalf, siting relevant legal arguments.**

**It was resolved by 9 in favour and 4 against (Cllrs Shing, Watkins, Martin and Mrs Berry) to convene a Special Council Meeting, called by Cllr M Cunningham and Cllr G Carter, in order to discuss the financial implications.**

### **b) Letting of Wannock Offices**

**It was resolved by 9 in favour and 4 abstentions (Cllrs Shing, Watkins, Martin and Mrs Berry) not to proceed with the letting of the Wannock Offices until the application for Town and Village Green had been determined.**

### **c) Polegate Football Club**

**It was resolved by 9 in favour, 3 against and 1 abstention (Cllr Mrs Berry) that a lease would be granted to Polegate Football Club for 1 year with a clause which clearly states that if Town and Village Green Status is granted, the license may be cancelled and the Club may not be able to continue to hire the facilities as currently.**
