New Committee structure

A new structure has now been implemented by the Council. There are four main committees: Finance & Policy; Environment & Leisure; Planning; Personnel. The former being held bi-monthly and the latter two being held as and when required. The Council have also implemented the following advisory committees: Building & Land; Festivities & Town Appearance; Transport & traffic; Youth & The Elderly. The advisory committees report back to the relevant committees with information specific to an agenda item for that committee. These advisory committees and main committees have been organised to provide greater clarity of which committee deals with which activities.

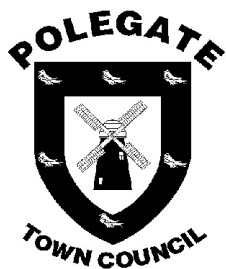

Allotments in Polegate

Polegate Town Council maintain and run two allotments in Polegate, Cophall & Gosford Way. Recently the Council have changed the way the waiting list is administered to ensure that Polegate residents have the first opportunity for an allotment. New plots are generally 5 rods and the new maximum for any one plot holder is 10 rods. Plots must be kept in a good and cultivated condition at all times. Full Council meet once a month to agree all items raised at the various committees. Members of the public are invited via an agenda which is posted on the website www.polegate-tc.co.uk and on the notice board at the front of the Council offices. Often agendas and minutes are also published in our other notice boards at the Dinkum, Stud farm and Wannock Road along with Council notices and events.

Planning Issues

Polegate has dealt with a large number of planning applications over the last few months including some controversial ones. Much of the high street will change under some of these plans. But empty shops are seen to be an eye sore in the high street.

Polegate Town Council are consultants on all plans within the Polegate area however it is important to remember that Wealden District Council have the final say in any approval or rejection of plans.

Polegate boundary does not include the Tower Mill application, which has now been approved by

Wealden. These plans are actually under Willingdon and Jevington Parish Council. Polegate Town Council are in contact with the local Drs to see if anything can be done to keep a satellite surgery in the high street for our residents further away, such as Dittons road. Plans are now with the NHS and in due course Polegate will find out the outcome of this and the affect on our residents.
